CAMPUS RULES FOR ADULTS

1. Participants are responsible to the Director of the Campus. Everyone participates as a group for scheduled activities. Except for group activities, when an individual leaves the campus, he or she must complete the sign-out sheet or contact the Director before leaving the residence, and sign in when returning.
2. Attendance is required at all scheduled activities, including meals.
3. Promptness is required for all scheduled activities. The group will not wait for the late individual.
4. In the residence, rooms should be absolutely quiet after 11:00 p.m.. Hotels have other guests, and excessive noise is unwarranted.
5. Absolutely NO DRUGS ARE PERMITTED! Europeans deal VERY SEVERELY with anyone using drugs or having drugs in his or her possession. Program participants found with illegal substances will be immediately dismissed from the program and are subject to the laws of the host country.
6. PARTICIPANTS WILL OBSERVE THE U.S. LEGAL AGE FOR THE USE OF ALL ALCOHOLIC BEVERAGES. This includes hard liquor, wine, and beer. Absolutely no alcoholic beverages may be in an underage student's room at any time.
7. Every participant agrees to respect others' wishes as to smoking. Therefore, smoking should not take place on buses, in crowded areas, or at mealtime.
8. Participants should carry the following information with them at all times: the name, address and telephone number of the resident lodging.
9. Participants must obtain a SECURITY POUCH OR MONEY BELT to be worn at all times from departure until the return from the foreign country. The passport, credit cards, and large bills (cash money) are secured in this way.
10. Adult participants may not associate in any way with Minor students after 11:00 p.m. unless as part of a Program activity or if authorized by the Program Director.
11. Participants are solely responsible for any legal problems encountered with foreign nationals or the governments of host countries. The Program is not responsible for providing any assistance under such circumstances.
12. Participants under 21 years-old may not operate motorized vehicles while traveling on the Program. Furthermore, the group (nor an individual of the group) does not attend events where large crowds gather. This prohibition includes rock concerts, soccer matches and any other event deemed inappropriate by the Director of the tour.

Any serious infraction of the rules will be dealt with immediately. If necessary, as a last resort when the Director, Advisor, and participant can not solve the problem, the participant will be asked to leave the Program at his own expense.

I understand that if I leave the program or am expelled from the program for any reason, there will be no refund of fees already paid, and that I am obligated to pay any remaining costs. It is important that NOTHING OCCURS THAT WILL ADVERSELY AFFECT THE INDIVIDUAL, OTHER PARTICIPANTS OR THE GROUP AS A WHOLE.
