## **CAMPUS RULES FOR MINORS**

1. Students are responsible to their Advisor and to the Director of the Campus. Everyone participates as a group for scheduled activities. During the day, TWO or more individuals may plan activities that are away from campus with the Advisor's or Director's knowledge. Each individual **MUST** complete the Sign-Out Sheet **BEFORE** leaving the campus, giving the required information.
2. During evening and night activities, "Minor" students will be accompanied by an Advisor or the Director. Exception to this rule (for any reason) must be cleared by an Advisor or the Director.
3. Any student who wishes to visit relatives or friends away from the residence must have the prior written permission from parents. The written permission must be filed with the Director **BEFORE DEPARTURE**.
4. Attendance is required for all scheduled activities, including meals.
5. Promptness is required for all activities. The group will not wait for the late individual. Unwarranted absence from a scheduled activity may restrict a student from the night activities.
6. All students are required to be in and remain in their own rooms after 11:00 at night unless they are returning from an authorized activity. The schedule is very strenuous for anyone not receiving proper rest. Because our hotels have other guests, excessive noise at any time is unwarranted.
7. Girls and boys may be in each other's room **WITH THE DOOR UNLOCKED**. If warranted, staff members may enter an unlocked room with adequate warning.
8. Absolutely **NO DRUGS ARE PERMITTED!** Europeans deal **VERY SEVERELY** with anyone using drugs or having drugs in his or her possession. Program participants found with illegal substances will be immediately dismissed from the program and are subject to the laws of the host country.
9. **STUDENTS WILL OBSERVE THE U.S. LEGAL AGE FOR THE USE OF ALL ALCOHOLIC BEVERAGES.** This includes hard liquor, wine, and beer. Absolutely no alcoholic beverages may be in a student's room at any time.
10. Students are solely responsible for any legal problems encountered with foreign nationals or the governments of host countries. The Program is not responsible for providing any assistance under such circumstances.
11. Students may not operate motorized vehicles while traveling on the Program.
12. The group does not attend or participate in events such as rock concerts, soccer events, etc. where large crowds are gathered.
13. Students agree to respect others' wishes as to smoking. **NO SMOKING WILL BE PERMITTED** on buses or in crowded areas.
14. Students should carry the following information with them at all times: the name, address, and telephone number of the resident hotel.
15. Students must arrange to have a **SECURITY POUCH** or **MONEY BELT**, which must be **WORN** at all times from departure until the return from Europe.

Any serious infraction of the rules will be dealt with immediately. If necessary, as a last resort when the Director, Advisor, and student can not solve the problem, the guardian will be called at the guardian's expense to help resolve the problem. If all attempts are unsuccessful, the student will be sent home at the family's expense. I understand that if I leave the program or am expelled from the program for any reason, there will be no refund of fees already paid, and that I am obligated to pay any remaining costs. It is important that **NOTHING OCCURS THAT WILL ADVERSELY AFFECT THE INDIVIDUAL, OTHER PARTICIPANTS OR THE GROUP AS A WHOLE.**
