STUDENT TERMS AND CONDITIONS

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY. Your signature indicates your acceptance in an international travel program, which is implemented by Europe Grand Tour, LLC. Each program is supervised by the director and guide in charge of international travel programs.

INCLUDED IN THE COST OF THE PROGRAM : round-trip airfare from Tampa; accommodations with private bath; hotel taxes and service charges as indicated in a particular program; land transportation (except within cities); airfare within Europe; transfers; breakfast and one main meal daily unless indicated otherwise in the itinerary; and entrance fees to museums and historical sites which are designated in morning itineraries.

NOT INCLUDED IN THE COST OF THE PROGRAM: Passport fees; visa fees (if required); personal expenses; beverages with meals (except breakfast); any reimbursement for missed travel connections, or delays; cost for single accommodations; and any expenses incurred for a participant by a Director or Advisor for medical or other reasons. A ruling by the Florida Legislature requires that students demonstrate adequate insurance coverage for illness and accidental injury abroad. A policy, which includes baggage and cancellation coverage and the above coverage is offered by Travel Guard through Europe Grand Tour's website. It also offers pre-departure cancellation should a medical emergency keep the students from participating. It is the full intent of Europe Grand Tour, LLC to complete each tour. This being the case, trip cancellation insurance would reimburse funds paid into the program if a participant chooses not to travel. Participants who do not have trip cancellation coverage in force are required to sign a waiver stating that they have been made aware of the necessity of said coverage and have willingly declined coverage.

The Director and/or Advisor of the campus will secure medical care and/or treatment for any illness or accident suffered by a participant during the travel program. The participant (and the guardian, if participant is under eighteen) agrees to release and hold harmless the director and/or the advisors, and Europe Grand Tour, LLC and their agents, from any liabilities resulting therefrom.

Europe Grand Tour, LLC and/or their agents cannot be held responsible for events beyond their control, such as acts of God, strikes, hijacking, acts of war or terrorism, or government restrictions; nor in the absence of their own negligence, for personal injury, death, or property damage caused by persons not controlled by them, such as airlines, bus or train companies, hotels, etc. They also reserve the right to make such changes in the itinerary or programs as may be beneficial for the participants and the carrying out of the programs. The cost of the program is based on the currency rates of exchange, airfares, and operating costs. The cost is subject to change to reflect any subsequent increases in foreign currency rates, fuel surcharges or airfare costs.

Payments for late enrollees must be brought up to date upon submitting their Application. Anyone enrolling after payments have been made overseas may be charged an additional \$100 for charges to cover overseas arrangements.

If the published exchange rate of the Euro to the dollar rises from the time that the budget cost was initiated to the time final payments are made abroad, participants may be required to pay this difference

PAYMENTS: A deposit of \$500, which will be applied to the total cost, must accompany the completed application and agreement forms. The amount is refundable minus a \$50 processing fee, should withdrawal be requested prior to October 1. Upon receipt of the deposit, Europe Grand Tour, LLC will present a schedule of payments with the final payment due on March 1. In order to control overhead costs, this schedule should be followed. Each payment must be received by the 10th of the month to avoid a late payment fee of \$30.00. The schedule of payments is as follows: a payment of \$670 is due October 1; \$670 is due November 1; \$670 due on December 1; \$670 due on January 1; \$670 due on February 1, and payment-in-full by March 1. A late fee of \$100.00 may be charged if full payment is not received by processing of air tickets.

CANCELLATION POLICY: Any request for withdrawal from the program must be in writing and mailed to Europe Grand Tour, LLC, with the post mark determining the date of withdrawal. Prior to October 1, a full refund will be given less a \$50 processing fee. After October 1 and prior to November 1, a full refund will be given less a \$500 cancellation fee; after November 1 and prior to January 1 a full refund will be given less an \$800 cancellation fee; and after January 1, no refund will be given.
